We are committed to performing and conducting our business with the utmost respect for ethical standards, ensuring integrity, transparency and compliance with applicable laws.

We will not practice bribery.

The payment of bribes or acceptance of any goods is prohibited.

We will not tolerate money laundering and/or the financing of terrorist activities.

We engage in the Know Your Customer activity.

We undertake to make full and detailed disclosure of the characteristics of the products we sell.

We undertake to take appropriate procedures in order to ensure integrity and security in product shipments.

We commit ourselves to the principles of confidentiality and protection of confidential data.

We are committed to upholding responsible conduct throughout the supply chain of its industry, ensuring that its Business Partners (Suppliers and/or Subcontractors) also observe business practices that are ethically sustainable and compliant with applicable laws and regulations, and ensuring the proper implementation of "Due Diligence for Responsible Sourcing from Conflict and High Risk Areas," in accordance with the requirements of RJC COP 2019, item 7, and the OECD Guidance.

We are committed to ensuring measures for product security within the premises and during shipments to prevent theft, damage, or replacement.

We are committed to maintaining the safety and well-being of Employees, Visitors and other relevant Business Partners.

We believe in and are committed to respecting fundamental human rights and the dignity of the individual, according to the Universal Declaration of Human Rights as enshrined in the United Nations.

We do not tolerate the use of child labor.

We pledge not to use any form of forced, bonded, indentured, or prison labor, and not to restrict the freedom of movement of employees and subordinate workers.

We are committed to high health and safety standards in our headquarters and operations.
